Located on the corner of a busy intersection, the store has great visibility and a desirable drive-thru window, making it Flagstaff's premier liquor destination. In addition to a drive-thru, the location also includes in-store pickup and a variety of local delivery services. The store offers a wide selection of spirits, beers, and specialty liquors to suit every taste and occasion, including Arizona made brews.

With a friendly staff and long history of operations at this convenient location the new owner will enjoy consistent revenues for many years to come.

Real Estate Location

The building is a one-story, concrete block structure with a reinforced concrete foundation and a pitched roof with asphalt shingles. The exterior windows are double pane glass, including a drive-thru window. The interior finish consists of vinyl floor planks and polished/sealed concrete flooring, textured painted drywall and exposed interior walls, wood slats and exposed ceilings, and LED and incandescent light fixtures.

The owners have invested approximately \$500,000 in renovations into the property over the last three years. Renovations included a new roof, interior and exterior paint, new asphalt paving (parking lot), flooring, and FF&E equipment including coolers.


